- **Stream Planting.** (by Chuck Godfrey) We have ordered a lot of bare root seedlings, willows and some riparian corridor plants, for planting on the Wiscoy (no-kill section) and for Oatka Creek just south of Warsaw. The Oatka section will be planted in conjunction with a massive stream bank protection effort initiated by the Wyoming County SWCD last summer and fall, and should help not only to stabilize the bank in that area but also to add shade to the creek in an area that has potential for increased populations of wild trout. The headwaters and upstream sections of Oatka maintain healthy populations of wild trout. We expect the trees to come in late in April, for planting then and in early May.

Editor's Note by Russ Shefrin

The January, 2008, chapter meeting of WNY TU included the annual presentation by DEC staff. I would like to summarize a few of the points which were made. (As usual, a great deal of valuable information was shared at the meeting, both during the formal lecture and during the discussion afterwards. What follows is only a small sample. All the more reason for chapter members to attend these meetings.)

A report was presented on 2007 research projects involving four nine-inch limit streams, namely Clear Creek (Arcade area), Hosmer Brook, Lime Lake Outlet, and McKinstry Creek . Procedures included angler diaries, electrofishing, and a temperature study. For all four streams combined, the angler diaries recorded a total of 161 brown trout caught (98% released) and 877 rainbow trout caught (98% released). The catch rates, recorded in the angler diaries, on all four streams reach or exceed the state wide goal of one trout per hour. (It was explained that angler diary data tend to reflect the efforts of more skilled fishers. These results may not be typical of the “average guy (or gal)”.

Electrofishing results for brown trout ranged from 294 per mile in McKinstry Creek to 617 per mile in Clear Creek. Rainbow trout numbers varied from 295 per mile (Hosmer Brook) to 1182 per mile in Clear Creek.

The temperature study revealed one factor in the relatively high productivity of Clear Creek. It turns out that this stream’s temperature parameters are quite favorable to trout. Even though the air temperature during the summer of 2007 reached well into the nineties on a (thankfully) few occasions, day time highs in the water reached only the low seventies. Moreover, the water temperature recovered well at night. A marginal trout stream will often not cool off as much as Clear Creek does after a hot day.

The DEC presentation also included a description of 2007 habitat work on McKinstry Creek. This project included 2500 feet of stream improvement by the Department of Transportation as mitigation for the first section of Route 219. The work involved bank stabilization and pool creation. Apparently, one of the problems with McKinstry Creek is that the bed elevation had decreased so much that the stream was less likely to overflow its banks during high water events. Naturally occurring overflows of this nature, we learned, can actually be beneficial to stream habitat, because they allow the energy of rushing water to be dissipated in the flood plain. Otherwise, the flood waters spend their energy eroding banks, etc.

Finally, DEC reported on a brook trout project in Allegany State Park. This work, planned to begin in the summer of 2008, is intended to create pools on McIntosh Creek. Though brook trout are present in the Park, streams there tend to lack pools during low flow periods. It is hoped that, by dropping and anchoring trees in selected areas, the resulting pools, which provide refuge for trout, will be able to endure the low water periods. This project involves a number of groups and will likely provide some volunteer opportunities for WNY TU members.

Our thanks go to Scott Cornett for his fine presentation and to James Zanett and Joseph Evans for their valuable contribution.
