- **A Report from Chuck Godfrey:**

**Wyoming County Soil and Water Conservation District Award:** "On October 16, WNYTU President Gary Coons and Stream Projects Chairman Chuck Godfrey represented the chapter as guests at the Wyoming County Soil and Water Conservation District's annual dinner. The SWCD had decided to inaugurate the Ronald P. Herman, Sr., Partners in Conservation Award in honor of a long time member of the SWCD's Board. The plaque reads "For outstanding achievement and dedication to the stabilization of stream channels and the restoration of trout habitat in Wyoming County." Gary and Chuck were honored to accept this first ever award on behalf of WNYTU. It recognized TU's commitment to our mission, which has been more evident in Wyoming County than in any other county in WNY. We've most recently participated in the North Branch of Wiscoy Creek Project, which will be completed in 2012; but we have worked for over 40 years on the main Wiscoy Creek, Cattaraugus Creek, Oatka Creek, East Koy Creek, and their watersheds. We continue to maintain our commitment to the resource as well as our commitment to partnering with other groups to protect and to enhance coldwater fisheries in WNY. Finally, we need to recognize that most of what we do in the way of actual instream work would not be possible without the tremendous efforts of personnel from the DEC and, more recently, the US Fish and Wildlife Service, based in Amherst. They do all the planning and groundwork for the projects in which we participate." ## Articles and Photos

A Tribute to Steve Mooradian

On November 16, 2011, Western New York lost a fine gentleman and a friend of outdoorsmen and women throughout Region 9. Steve Mooradian passed away of a heart attack in Hawaii while celebrating his 40th wedding anniversary with his wife, Eunice. He will be sorely missed.

Over the years, we have participated in many stream projects which would not have been possible without the support of Steve and his willingness to commit DEC personnel and money to planning and to carrying out those projects. Thanks to Steve's involvement, over a period of many years, work was carried out on Wiscoy Creek, Hosmer Brook, the upper Cattaraugus Creek, East Koy Creek; and I'm probably forgetting some. (Many of those projects took place so long ago that they are not familiar to newer members of our organization.) It was a great tradition of support which he began and which continued under Paul McKeown, his successor as Regional Fisheries Manager, and, now, Mike Clancy, Paul's successor.

I know when I was WNYTU president, I used to attend the TU State Council meetings; and, when we would report on what we had done in the Region, many other TU chapters from across the state would ask how we managed to get such cooperation from the DEC; because they perhaps did not have as good a relationship with the Fisheries folks in their Regions. Well, it started at the top, with Steve Mooradian's believing in us and our mission and supporting it.

Here is just one example of how Steve cooperated with us to get done what needed to be done in the Region. I first had personal contact with Steve at an Erie County Federation meeting in September of 1986. This was the meeting at which the DEC personnel of the Region traditionally gave reports to the Federation, renewed old acquaintances, and enjoyed hot dogs and corn, courtesy of the SFS. That particular evening, Steve recounted how, earlier in the day, his Fisheries people had had to cancel an electroshocking survey because of a shortage of personnel due to an illness or two, a tech's being called onto another project, and probably something else which I do not recall. He said this had happened during the summer also. I approached him after the meeting and mentioned that I was a teacher with most of the summer free, that TU had other teachers who were free in the summer, as well as a bunch of older, dedicated, retired members who would probably be able to be available in the summer. I asked if it was permissible to use non-DEC personnel on the electroshocking surveys. Steve responded that it could be done. So I proposed that we put together a list of TU members who might be able to help with electroshocking if the need arose,

and he agreed. I published a request, in a couple of successive newsletters, asking for volunteers. We generated a list which was forwarded to Steve for his folks – at the time, mostly Joe Evans and Jim Pomeroy – to use if needed. The next summer, some of us started to get phone calls – remember this was long before the days of emails – and letters with lists of days when help could be used. This was the start of the DEC’s extensive use of our members as volunteers on electroshocking in Region 9, and it was due to Steve’s willingness to be innovative. Incidentally, upon Steve’s retirement, Region 9 DEC established the Stephen R. Mooradian Fisheries Partnership Award in his honor.

On November 23, 2011, I attended Steve’s funeral in Obi – prior to this I didn’t even know there WAS an Obi, NY – and listened as friends and members of his church community extolled his virtues and told stories of good times with Steve. If you knew him at all, you know there were lots of good times and many great stories. I got to meet his wife, Eunice; and she recounted the following story to me. She said that, many times, the job could be wearing. Sometimes, after a meeting, Steve would return home and mention that it was nice that everyone at the meeting knew his job better than he did. I can empathize with that, as I’ve attended meetings where people have treated DEC folks like that. At any rate, he returned late one night and woke her up to tell her about the “meeting” he had attended that evening. It was the night he received the “Silver Trout Award” from our chapter. He told her it was a highlight of his career to receive that award from us and to hear the applause and ovation he received, and that he still felt that way until the end. I wasn’t able to make it, but I’m told the award was proudly displayed at his viewings on Tuesday, and I’ve since heard the same story from another person who was unable to make the funeral but contacted Eunice to reminisce about Steve.

WNY outdoorsmen and women and conservationists lost a great friend, supporter, and advocate when we lost Steve. Those of you who receive the electronic newsletter will have a picture of the sign outside the church for the funeral. For those who don’t, it says “We praise God for Steve Mooradian, a man of God. You will be missed.” Truer words were never spoken.

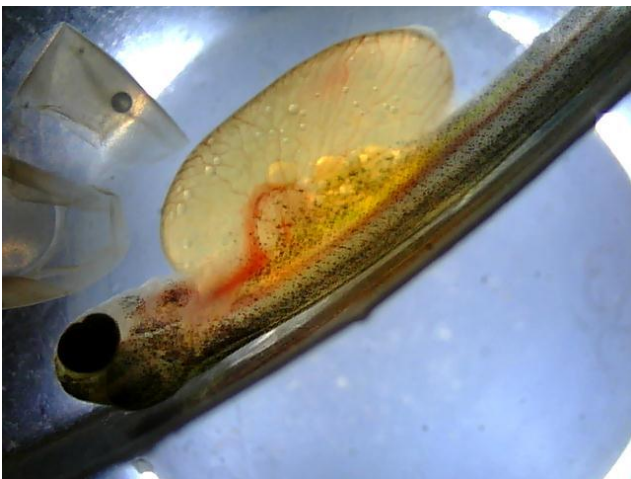

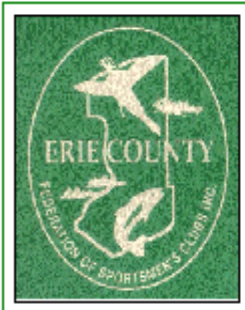

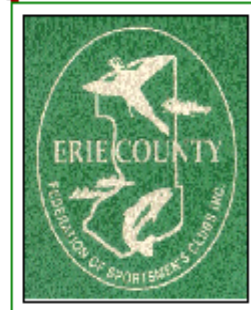
